## Free Tax Help from Baltimore CASH Campaign

Not everyone needs to file a federal tax return. But if you're under age 65 and earn at least \$9,350 — or double that amount if your married filing jointly — Uncle Sam requires you to file a return.

Good news, you don't have to pay to have your returns prepared in many cases.

The Baltimore CASH (Creating Assets, Savings, and Hope) Campaign this morning is announcing 20 sites in Baltimore city and county for free tax preparation for families with incomes under \$49,000 and singles with income under \$25,000. The nonprofit expects to prepare 16,000 tax returns this season.

If you are within these income limits, also check whether you are eligible for the Earned Income Tax Credit by calling United Way's First Call for Help at 410-685-0525 or visiting the nonprofit's [online site](#). The credit is worth thousands of dollars, and Baltimore CASH Campaign estimates that city residents miss out on \$29 million in EITC money each year because they fail to claim the credit.

One feature new this year is that taxpayers will be able to mark a box on their tax return to have all or some of their refund moved into U.S. Savings Bonds, the nonprofit noted.

Also for the first time, the Baltimore CASH Campaign will help families fill out the Free Application for Federal Student Aid (FAFSA) form to qualify for federal student aid. fAFAS
